Privacy Policy

1. Introduction

Welcome to Quosiom (“we”, “our”, “us”). We are committed to protecting your personal information and your right to privacy. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our website www.quosiom.com, including any other media form, media channel, mobile website, or mobile application related or connected thereto (collectively, the “Site”). Please read this privacy policy carefully. If you do not agree with the terms of this privacy policy, please do not access the site. Logging in to our website shall be considered acceptance of the Terms and Conditions mentioned herein.

2. Information We Collect

We collect information about you in a variety of ways. The information we may collect on the Site includes:

Personal Data

- Personally identifiable information, such as your name, shipping address, email address, and telephone number, and demographic information, that you voluntarily give to us when you register with the Site or when you choose to participate in various activities related to the Site, such as online chat and message boards.

Derivative Data

- Information our servers automatically collect when you access the Site, such as your IP address, your browser type, your operating system, your access times, and the pages you have viewed directly before and after accessing the Site.

Financial Data

- For affiliates, we store the data our affiliates choose to provide us with for making payments to them.

Cookies and Tracking Technologies

- We use cookies and similar tracking technologies to monitor activity on our Site and store certain information. Cookies are files with a small amount of data that may include an anonymous unique identifier. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Site.

3. Information we DO NOT collect or store at our servers

Financial Data

- ALL Payment Details such as (Credit Card Numbers, OTPs etc.) related to payment (for our service fee) are directly given to the Payment Gateway (such as RazorPay).
- We DO NOT store Credit Card Numbers or any other data which may enable us to COLLECT Payment or Charge you without your consent.
- We only collect the derivative payment data (such as Transaction ID, Payment Date, etc.) in relation to the service fee that you pay for using our Website through the Payment Gateway.

4. How We Use Your Information

Having accurate information about you permits us to provide you with a smooth, efficient, and customized experience. Specifically, we may use information collected about you via the Site to:

- **Create and manage your account:** Including processing your registration, verifying your identity, and providing you with access to your account.
- **Process your transactions:** Including sending you related information, such as purchase confirmations and invoices.
- **Improve our website and services:** Including understanding and analyzing how you use our website and services, and developing new products, services, features, and functionality.
- **Communicate with you:** Including for customer service, to provide you with updates and other information relating to the website, and for marketing and promotional purposes.
- **Send you text messages and push notifications:** Including updates and other relevant information.
- **Find and prevent fraud:** Including monitoring and analyzing activity on the Site to detect and prevent fraudulent transactions and other illegal activities.
- **For compliance purposes:** Including enforcing our Terms of Service, or other legal rights, or as may be required by applicable laws and regulations or requested by any judicial process or governmental agency.

4. Sharing Your Information

We may share information we have collected about you in certain situations. Your information may be disclosed as follows:
